- Upon signature, Photography by E shall reserve the time and date agreed upon. A non-refundable deposit in the amount of \$100 is required for each session, unless otherwise stated in writing. This deposit must be paid at the time of booking. Full payment required the day of the session. *No part of any order, including previews, will be delivered until the session fee is paid in full.
- If, in the opinion of the photographer, inclement weather or other adverse conditions prevent the creation of a portrait meeting the artistic standards of Photography by E, the photographer may elect to use an alternate location or to reschedule the portrait session, at no cost to the client.
- The charges implied in this Contract are based on our Standard Price agreement. This price agreement is adjusted periodically and future orders shall be charged at the prices in effect at the time when the order is placed.
- If Photography by E cannot perform this Contract due to fire or other casualty, act of nature, or other cause beyond the control of the parties, or due to Photographer's illness or emergency, then the Photographer shall return the deposit to the Client but shall have no further liability with respect to the Contract. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunction, or otherwise lost or damaged without fault on the part of the Photographer. Photography by E shall not be liable for any amount in excess of the retail value of the Client's order.
- Photography by E reserves the right to use images created under this contract for advertising, display, publication or other purposes.
- **Notice of Copyright:** It is illegal to copy or reproduce these photographs elsewhere without permission of Photography by E. Digital files and previews remain the exclusive property of Photography by E, unless otherwise written with the purchase of copyright release.
- Reasonable requests for particular photographs will be given every effort to achieve. Please note that some venues and/or officials place limitations and restrictions on photography. It is the responsibility of the client to notify the photographer of such restrictions and/or to gain permissions for requested images outside of the venue's standard restrictions. Photography by E will not be held responsible for the results of such limitations (i.e. no flash photography).
- Any modifications of this Contract must be in writing and signed by both parties.
- The Client signing this contract warrants that he or she has actual authority to agree to the use of the likeness of all persons included in the portrait in this manner and shall indemnify and defend Photography by E in the event of litigation arising out of such use (i.e. group photos).
